On 11/11/18 at about 1919 hours dispatch notified units of a woman who was making threatening statements at a public gathering at the Native Sons Hall in Murphys. I spoke with RP-Elizabeth Graham over telephone.

I asked RP-Elizabeth what happened. RP-Elizabeth told me that S- [REDACTED] had been causing issues. I asked RP-Elizabeth what kind of issues S- [REDACTED] was causing. RP-Elizabeth told me S- [REDACTED] was not a member of the Native Sons and was interrupting their gathering. RP-Elizabeth told me S- [REDACTED] would keep trying to use the microphone to sing. RP-Elizabeth told me S- [REDACTED] said something about killing the women attending the gathering to W-Kevin Siewert. I asked if RP-Elizabeth had ever heard anything similar from S- [REDACTED] RP-Elizabeth told me in her six years at the Native Sons, she had never had an issue with S- [REDACTED] I asked RP-Elizabeth what she would like the Sheriff's Office to do for her. RP-Elizabeth requested that a written report be taken so she could have documentation of the incident. RP-Elizabeth gave me W-Kevin's phone number so I could further investigate.

I called W-Kevin. I asked him what had happened in regards to S- [REDACTED]. W-Kevin told me that S- [REDACTED] kept trying to use the microphone. W-Kevin said he asked S- [REDACTED] to go outside and talk with him for a while. W-Kevin told me while speaking with S- [REDACTED] that she said, "One of these days I'm going to kill those fucking women." W-Kevin told me S- [REDACTED] used similar verbiage approximately five more times in an approximate one and a half minute span of time. W-Kevin said there were no specific threats made. W-Kevin told me he was able to successfully calm down S- [REDACTED] and divert her attention from the gathering inside by asking her questions. W-Kevin told me this was the first time he had ever met S- [REDACTED]. W-Kevin told me they pretended to close down the hall for the evening so S- [REDACTED] would leave. W-Kevin said he and his wife gave S- [REDACTED] a ride to her home in Murphys with no further outbursts from S- [REDACTED]

I called RP-Elizabeth back and gave her my name and case number for reference. I told RP-Elizabeth to call me if she had any more information.
