Additional Conditions required by Hawaii Film Office:

1. Permit valid only at locations listed on the "Open/Accessible DLNR-administered Sites" Hawaii list which can be downloaded from <http://filmoffice.hawaii.gov/film-permitting/openaccessible-sites/>. [NOTE: Some of the locations on the list also require County approval. Applicant must obtain the appropriate County approval.];
2. Please note that certain locations are not approved for filming on weekends and holidays and be especially accommodating to the public's use of the locations on your weekend shoot days;
3. This permit is valid only for land based activity, including activity on the shoreline/wet sand areas of beaches. Water activity, such as, but not limited to, swimming, water sports, underwater activities and the use of water vessels, are not approved for this permit. Adhere to all beach closure notices and posted warning signs;
4. No nudity or sexual/erotic acts on public property;
5. Operational hours posted at the location supersede the hours on this permit; and
6. This permit is limited to Four (4) vehicles and the applicant cannot use more than half the stalls in state park and state beach parking lots. Applicant must discuss the parking considerations at County beach parks with the County.
