## SUMMARY:

The film centers around a young girl whose father, driven by the societal pressure to have a male child, shows a deep dissatisfaction with having a daughter. This powerful short film encourages reflection on the pervasive issue of gender discrimination and the need for societal change, particularly in cultures that place disproportionate value on having a male child.


